INVITATION TO BID FOR:

**SUPPLY, DELIVERY AND INSTALLATION OF
TRANSFORMER FOR CSU ANDREWS CAMPUS
(PROJECT REF. No.: CSU2019-02-002-PSS)**

The **CAGAYAN STATE UNIVERSITY (Andrews Campus)**, through the *Corporate Budget for the contract approved by the governing Board* intends to apply the sum **Two Million Six Hundred Eighty Thousand Pesos and 00/100 (2,680,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for SUPPLY, DELIVERY AND INSTALLATION OF TRANSFORMER FOR CSU ANDREWS CAMPUS (PROJECT REF. No.: CSU2019-02-002-PSS). Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The **CAGAYAN STATE UNIVERSITY (Andrews)** now invites bid for the following:

Items to be bid are offered as One (1) lot, and the basis shall be the offer or bid for the entire Lot covering all the work items required to complete the project. Incomplete bid shall be rejected.

Delivery of the Goods is required at least Ninety (90) working days. Bidders should have completed, within at least the past two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.

2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, whose business is registered in Region 2

- Interested bidders may obtain further information from **CAGAYAN STATE UNIVERSITY** and inspect the Bidding Documents at the address given below from Monday to Friday (8:00A.M – 5:00 P.M), beginning **February 11, 2019** until **March 04, 2019**.

A complete set of Bidding Documents may be purchased by interested Bidders beginning **February 11, 2019** until **March 04, 2019**. From the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- The **CAGAYAN STATE UNIVERSITY** will hold a Pre- Bid Conference on **February 20, 2019**. 9:00 AM at Conference Room, Administration building, CSU Andrews Campus.
- Bids must be delivered to the BAC Secretariat Office, Cagayan State University, Andrews Campus, Tuguegarao City on or before **March 04, 2019**, at exactly 9:00 AM, and the same must be stamped received by the Head of the BAC Secretariat or his representative. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause **Error! Reference source not found.**

Bid opening shall be on **March 04, 2019**, at exactly 10:00 AM at Conference Room, Cagayan State University, Andrews Campus, and Tuguegarao City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. **LATE BIDS SHALL NOT BE ACCEPTED.**
