- f. The applicable and appropriate method of procurement and the related milestones: Public Bidding: Single LOT
- g. The prospective bidders are given to raise their Queries and clarification until Feb. 10, 2023, 5:00 pm under 22.5.1. Requests for clarification(s) on any part of the Bidding Documents or for an interpretation must be in writing and submitted to the BAC of the Procuring Entity concerned at least ten (10) calendar days before the deadline set for the submission and receipt of bids. The BAC shall respond to the said request by issuing a Supplemental/Bid Bulletin, duly signed by the BAC Chairperson, to be made available to all those who have properly secured the Bidding Documents, at least seven (7) calendar days before the deadline for the submission and receipt of bids.

Deadline of submission clarification: May 5, 2023, 5:00 pm

- h. Eligibility requirements the prospective bidders need to submit are included in the Bidding Documents and the former are advised to read such;
- i. Discussion on the evaluation procedure and criteria under 30.1. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed."
- j. Reminded the body the possible causes of failure of bidding, grounds for disqualification, suspension and blacklisting; that It is mentioned in the BID DOCUMENTS, in case of Bid Securing Declaration, there is a waiver of due process for blacklisting and automatic blacklisting in case of violation of any conditions stated.

- k. Reminded the body the prospective bidders regarding the Right of the HoPE under Section 41 (reservation clause): The HoPE reserves the right;
 - to reject any and all bids
 - ii. declare a failure of bidding, or
 - iii. not award the contract in the following situations:
 - 1. If there is prima facie evidence of collusion
 - 2. If the BAC is found to have failed in following the prescribed bidding procedures; or
 - 3. the award of the contract will not redound to the benefit of the CSU.

n. The end-user presented the items and specifications of the project.

II. Noted comment/reaction from the BAC, TWG and End-user:

- 1. Upon inquiry of Pronet Systems Inc. representative:
 - a. the Committee, through BAC Chairperson and End-user, explained that the installation does not refer to the cable installable but only to the setting up of the units, installation and activation of software and licenses;
 - b. The 100 pcs PASSTHROUGH RJ45 and 2 boxes of UTP CABLE CAT 6 (305M) are part of inclusions/scope of works as they were considered in the drafting of ABC; and
 - c. BAC member Mr. Roy further explained that RJ45 has minimal costing and the UTP CABLES need not be branded as it has to be changed regularly;
- 2. The Chairperson explained that the law only requires 1 copy of the requirements but the Committee is requesting for additional 2 copies for efficiency purposes;
- 3. BAC members Mr. Roy and Mr. Sumait emphasized that bidders may comply with the required specifications or offer higher ones;
- 4. Upon the request of both prospective bidders, upon consulting the end-user, the Committee has decided to amend the completion of delivery from 30 CDs to 45 CDs and INTEL CORE 15-2400 PROCESSOR OR HIGHER to INTEL CORE 15-12400 PROCESSOR OR HIGHER; and
